

CITY ORDINANCE 2015-05

**AN ORDINANCE OF THE CITY OF FULTON,
KENTUCKY INCREASING WATER AND SEWER
RATES FOR THE CITY AND WATER DISTRICT;
REPEALING ANY CONFLICTING ORDINANCES;
AND PROVIDING FOR EFFECTIVE DATES**

**BE IT ORDAINED BY THE BOARD OF COMMISSIONERS
OF THE CITY OF FULTON, KENTUCKY, AS FOLLOWS,
TO-WIT:**

SECTION ONE:

**(A) That the rates for water service per gallon for all water customers
located inside the city limits of the city of Fulton Kentucky are
hereby established as follows:**

SECTION TWO:

The above charges are in compliance with KIA (Kentucky Infrastructure Authority Loan Number A15-097 requiring our current water rates be adjusted by 15% by January 1, 2016 and the current sewer rates be adjusted by 12% by January 1, 2016. The new rates shall become effective July 1, 2015 which the new rates will appear on the June billing cycle.

SECTION THREE:

Per KIA (Kentucky Infrastructure Authority Loan Number A15-097) the water rates will be adjusted by July 1, 2017 by six percent (6%)

SECTION FOUR:

That all Ordinances or parts of Ordinances in conflict here-with are as to such conflict hereby expressly repealed.

SECTION FIVE:

If any clause, sentence, part or paragraph of the Ordinance is invalid, such invalidity shall not affect the remaining portions.

SECTION SIX:

This Ordinance shall be in full force and effect on and after its adoption, approval, and publication as required by law.
